**POLICY FOR PREVENTION OF SEXUAL HARASSMENT OF WOMEN**  
**AT WORKPLACE FOR EMPLOYEES OF STEWART SCHOOLS**  
**AND STEWART SCIENCE COLLEGE**

The Management has framed a guideline to constitute Internal Committee under Sexual Harassment of Women at Workplace-2011 (Prevention, Prohibition and Redressal Act, 2013) for all the Diocesan Institutions.

Presiding Officer who shall be a woman employed at a senior level at workplace from amongst the employees (If a senior level woman employee is not available, the Presiding Officer shall be nominated from other offices or administrative units of the workplace (Provided further that in case the other offices or administrative units of the workplace do not have a senior level woman employee, the Presiding Officer shall be nominated from any other workplace of the same employer or other department or organization. Not less than two Members from amongst employees preferably committed to the cause of women or who have had experience in social work or have legal knowledge;

One member from amongst non-governmental organisations (NGO) or associations committed to the cause of women or a person familiar with the issues relating to sexual harassment:

**INTERNAL COMPLAINT COMMITTEE**

- i.** Lady Principal/ Senior Lady Presbyter of the Diocese/ Lady Doctor/ Lady Coordinator / Lady Staff representative/ Senior Lady Teacher - Presiding Officer
- ii.** Registrar / Administrative Bursar Office Manager/ Finance Manager / – Member
- iii.** Gents Coordinator / Senior Gents Teacher/ Gents Staff representative – Member
- iv.** President/Secretary of DWFCs / Lady representative of other NGO /Social worker of DBSS/ ICDP / CHFH – Member

At least one-half of the total Members so nominated for Internal Complaint Committee shall be women.

Tenure of Internal Complaint Committee : Presiding Officer and every Member of the Internal Committee shall hold office for period three years, from the date of their nomination / appointment.)

Allowances :The Member appointed from amongst non-government organisations shall be entitled to an allowance of two hundred rupees per day for holding the proceedings of the Internal Committee and also the reimbursement of travel cost incurred in travelling by train in three tier air condition or air conditioned bus and auto rickshaw or taxi, or the actual amount spent by him on travel, whichever is less.

All the Diocesan Institutions to be intimated to constitute the said committee as per the direction.

**POLICY ON SEXUAL HARASSMENT OF EMPLOYEES**  
**IN THE DIOCESE OF CUTTACK,CNI**

**1.0 POLICY**

- 1.1 The DIOCESE OF CUTTACK,CNI is an equal employment opportunity religious organisation and is committed to creating a healthy working environment that enables employees to work without fear of prejudice, gender bias and sexual harassment. The DIOCESE OF CUTTACK,CNI also believes that all its employees, have the right to be treated with dignity. Sexual harassment at the work place or other than work place if involving employees is a grave offence and is, therefore, punishable.
- 1.2 The Supreme Court has also directed all organisation to lay down guidelines and a forum for redressal of grievances related to sexual harassment.

**2.0 SCOPE AND EFFECTIVE DATE**

- 2.1 This Policy extends to all employees of the Diocese of Cuttack, CNI and all institutions under its management and is deemed to be incorporated in the service conditions of all employees and will come into force with effect from 1<sup>st</sup> Oct 2011.
- 2.2 Sexual harassment would mean and include any of the following:
- i) unwelcome sexual advances, requests or demand for sexual favours, either explicitly or implicitly, in return for employment, promotion, examination or evaluation of a person towards any company activity;
  - ii) unwelcome sexual advances involving verbal, non-verbal, or physical conduct such as sexually coloured remarks, jokes, letters, phone calls, e-mail, gestures, showing of pornography, lurid stares, physical contact or molestation, stalking, sounds, display of pictures, signs, verbal or non-verbal communication which offends the individuals sensibilities and affect her/his performance;
  - iii) even teasing, innuendos and taunts, physical confinement against one's will and likely to intrude upon one's privacy;
  - iv) act or conduct by a person in authority which creates the environment at workplace hostile or intimidating to a person belonging to the other sex;
  - v) conduct of such an act at work place or outside in relation to an Employee of Diocese of Cuttack, CNI, or vice versa during the course of employment; and
  - vi) any unwelcome gesture by an employee having sexual overtones
- 2.3 "Employee" means any person on the rolls of the Company including those on deputation, contract, temporary, part time or working as consultants.

**3.0 COMPLAINT REDRESSAL COMMITTEE S FOR EXUAL HARASSMENT OF EMPLOYEES**

- 3.1 A Committee has been constituted by the Management to consider and redress complaints of Sexual Harassment. The Chairman and Members of the Committee are as follows:

**COMPLAINT REDRESSAL COMMITTEE**

- i. Dr.(Ms) R.R.Senapati -Chair person
  - ii. Ms. D. Martin
  - iii. Mr. F. C. North – Member
  - iv. Secretary of local WFCS – Member
  - v. Senior Most Lady Presbyter of the Diocese
- 3.2 A quorum of 3 members is required to be present for the proceedings to take place. The quorum shall include the Chairperson,at least two members, one of whom shall be a lady.

#### **4.0 REDRESSAL PROCESS**

- 4.1 Any employee who feels and is being sexually harassed directly or indirectly may submit a complaint of the alleged incident to any member of the Committee in writing with his/her signature within 10 days of occurrence of incident.
- 4.2 The Committee will maintain a register to endorse the complaint received by it and keep the contents confidential, if it is so desired, except to use the same for discreet investigation.
- 4.3 The Committee will hold a meeting with the Complainant within five days of the receipt of the complaint, but no later than a week in any case.
- 4.4 At the first meeting, the Committee members shall hear the Complainant and record her/his allegations. The Complainant can also submit any corroborative material with a documentary proof, oral or written material, etc., to substantiate his / her complaint. If the Complainant does not wish to depose personally due to embarrassment of narration of event, a lady officer for lady employees involved and a male officer for male employees, involved shall meet and record the statement.
- 4.5 Thereafter, the person against whom complaint is made may be called for a deposition before the Committee and an opportunity will be given to him / her to give an explanation, where after, an "Enquiry" shall be conducted and concluded.
- 4.6 In the event, the complaint does not fall under the purview of Sexual Harassment or the complaint does not mean an offence of Sexual Harassment, the same would be dropped after recording the reasons thereof.
- 4.7 In case the complaint is found to be false, the Complainant shall, if deemed fit, be liable for appropriate disciplinary action by the Management.

#### **5.0 ENQUIRY PROCESS**

- 5.1 The Committee shall immediately proceed with the Enquiry and communicate the same to the Complainant and person against whom complaint is made.
- 5.2 The Committee shall prepare and hand over the Statement of Allegation to the person against whom complaint is made and give him /her an opportunity to submit a written explanation if she / he so desires within 7 days of receipt of the same.
- 5.3 The Complainant shall be provided with a copy of the written explanation submitted by the person against whom complaint is made.
- 5.4 If the Complainant or the person against whom complaint is made desires any witness/es to be called, they shall communicate in writing to the Committee the names of witness/es whom they propose to call.
- 5.5 If the Complainant desires to tender any documents by way of evidence before the Committee, she / he shall supply original copies of such documents. Similarly, if the person against whom complaint is made desires to tender any documents in evidence before the Committee he / she shall supply original copies of such documents. Both shall affix his / her signature on the respective documents to certify these to be original copies.
- 5.6 The Committee shall call upon all witnesses mentioned by both the parties.
- 5.7 The Committee shall provide every reasonable opportunity to the Complainant and to the person against whom complaint is made, for putting forward and defending their respective case.
- 5.8 The Committee shall complete the "Enquiry" within reasonable period but not beyond three months and communicate its findings and its recommendations for action to the CEO Diocese of Cuttack, CNI. The report of the committee shall be treated as an enquiry report on the basis of which an erring employee can be awarded appropriate punishment straightaway.
- 5.9 The CEO Diocese of Cuttack, CNI will direct appropriate action in accordance with the recommendation proposed by the Committee.

5.10 The Committee shall be governed by such rules as may be framed by the Supreme Court orders or any other legislation enacted later on.

**6.0 OTHER POINTS TO BE CONSIDERED**

6.1 The Committee may recommend to the VP-HR action which may include transfer or any of the other appropriate disciplinary action.

6.2 The management shall provide all necessary assistance for the purpose of ensuring full, effective and speedy implementation of this policy.

6.3 Where sexual harassment occurs as a result of an act or omission by any third party or outsider, Diocese of Cuttack, CNI shall take all steps necessary and reasonable to assist the affected person in terms of support and preventive action.

6.4 The Committee shall analyse and put up report on all complaints of this nature at the end of the year for submission to CEO, Diocese of Cuttack, CNI

6.5 In case the Committee find the degree of offence coverable under the Indian Penal Code, then this fact shall be mentioned in its report and appropriate action shall be initiated by the Management, for making a Police Complaint.
